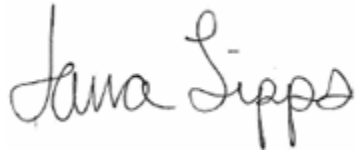

This facility was found to be in non-compliance with the following rules:


R 400.15401 Environmental health.

(2) Hot and cold running water that is under pressure shall be provided. A licensee shall maintain the hot water temperature for a resident's use at a range of 105 degrees Fahrenheit to 120 degrees Fahrenheit at the faucet.

During on-site inspection the water temperature was checked in three resident bathrooms, at the faucet. The water temperature did not register above 100 degrees Fahrenheit in two of the three bathrooms checked.

IV. RECOMMENDATION

Contingent upon receipt of an acceptable corrective action plan, renewal of the license is recommended.
