Foreword

International law is a fundamental area of law for the Kingdom of Tonga (Tonga) considering the ever-increasing globalized nature of this world. International law gives Tonga the right to be recognized as an independent and sovereign civilized nation, with full capabilities of engaging at the multilateral level on various issues of interest to Tonga, and to address common global problems.

This was recognized by the founder of modern Tonga, His Majesty King George Tupou I, when he enacted Tonga's Constitution of 1875 to meet the requirements of what was considered a "State" in the international law to protect Tonga's independence at a time of colonial rivalry. In the Constitution, Clauses 39 and 40 of the Act of the Constitution of Tonga granted His Majesty the authority to enter treaties with foreign states and to receive foreign representatives.

In today's world, it is vital that Tonga abides by international law which is comprised of Treaties, Convention, and Agreements which Tonga is a party to, and customary international law. Whilst there are benefits reaped from being a party to a Treaty, it is our collective responsibility to ensure obligations and commitments under these legal arrangements are kept. In doing so, Tonga must utilize its resources and capacity, despite how little, to ensure legal commitments and arrangements are kept. This will in turn contribute to Tonga's global profile as a committed, serious and integral player in the Global Community. It will also reflect Tonga's commitment to act in good faith.

To guide Tonga's international law work, upon a directive of His Majesty's Cabinet in 2018, the Ministry of Foreign Affairs and the Attorney General's Office were tasked with completing a Treaty Collection that would incorporate all Tonga's International Treaty Commitments.

It is with great pleasure that we present the First Edition of Tonga's Treaty Collection. Since the passing of Tonga's Constitution in 1875, Tonga has entered Treaties with the United Kingdom, Germany, France and the United States. To date, Tonga has ratified over 300 Treaties and Conventions.

It is our hope that this collection will assist the Government of the Kingdom of Tonga in ensuring Tonga upholds the rule of international law at the global and national levels.
